4. Discussion items

a) Guest presentation by Pete Maragos, constituency assistant and scheduler in MPP Han Dong's office. Due to unexpected late arrival of Mr.Dong, Mr. Maragos shared his accomplishments since the elections and his plans for the future. His main goal is to hear as many voices from the constituents so that the community can be well served. "A lot has been done but lot more can be done".

When Mr. Dong arrived, he shared his background and vision. He mentioned that since he was elected he met with all BIAs and resident's associations as he feels it is very important to work with the constituents. His main focus is on youth training, transit and OMB/planning, senior care and affordable housing. One question to Mr Dong was whether the new Condominium Act would contain provisions to make it less onerous to convert multi-unit houses to condos in order to enable people to downsize without leaving the neighbourhood.

Then Mr. Dong was given a background of challenging issues that the Disruption committee unsuccessfully dealt with over a few years such as inebriated patrons of College St. bars, lack of response to complaints, etc. Mr. Dong was asked for ideas and help in this area. He agreed to look into it. Tim thanked Mr.Dong and Mr.Maragos for taking time to come to the Board meeting and expressed trust that we will work together in the future.

b) Ward Boundaries review:

Sue gave the members a summary of what has happened so far: The City hired a planning group to investigate the size, geography, population mix and other information about the Wards. The group completed the information gathering and held 12 public meetings. The group is going to analyze the

results of the public meetings and come up with 5 suggestions sometime in the summer.

c) HV Facebook page

Discussion regarding HV Facebook or other social media included for and against arguments. It was concluded that at this time we'll continue using Twitter and that we will explore "how do we reach out to people and how best to connect with them"

d) Board Liability insurance It was agreed that the board members should be protected with liability insurance. Tim will circulate Leslie Thompson's review and the item will be put on next meeting's agenda.
