## a. Environment:

#### i. Trees:

Tim reported on behalf of Dinny Biggs that final report for the project was sent; about \$2,300 remained unspent. Over 200 trees were planted as a result of the project

#### c. Community Liaison

 Gus Sinclair reported that George Smitherman is going to talk on Oct 12<sup>th</sup> at Avenue Rd and Bloor

The election is on Oct 25<sup>th</sup>; there was a discussion whether HVRA should co-sponsor Councillors' & School Trustees' debate; suggested date Oct 14<sup>th</sup>; Robert Brown will be approached to organize

## d. Zoning:

• Sue reported on the concerns of illegal rooming houses: 80 Willcox is a semi; there is a proposal for conversion into a rooming house with extremely small rooms; neighbours are concerned that there will be an increase in noise (in addition to the noise generated by occupants of rooming houses on Spadina)

The owner is also planning to make changes to the front of the house; Sue gave him a letter re Heritage requirements.

b. Tim presented motion regarding Robert Street Playing Field/Ice Rink/Tennis Courts/Parkette: "Be it moved that HVRA ask the U of T to collaborate with neighbours and HVRA."

c. 783 Bathurst (former Loretto Abbey school bldg) – Tim asked for volunteers to attend meeting with Councillor Vaughan, and the architect and developer of a proposed 9 storey condo on Tuesday, July 27 at 3:00 somewhere in the Harbord Village. The building will have a 3 story podium and a narrower 6 story rise from there. Wendy, Katrina and Sue volunteered.

#### 7. Other Items

a. Racoons

Wendy brought up concerns from her neighbours regarding damage done by racoons; suggestions for remedy included "Do not feed" campaign, checking City web site for information and looking for articles done in the past by HVRA

b. Silent auction

Last year HVRA had 2 silent auctions- Pumpkin Festival & Fall Fair; suggestion was to combine soliciting for items for both; Gus will approach Jan to organize both

c. Fall Fair

Laura reported that the main application was approved pending other permits

d. Welcoming new residents

HVRA does not have an official process but individually members knew of various actions that immediate neighbours did when a new resident/family moved in
