1. Chair's Welcome extended to all

2. Approval of the Agenda

3. Approval of the Minutes of the May meeting Moved by Carmen and seconded by Neil - approved

4. Treasurer's report

Carmen reported that everything is in good shape. Spending is as projected except History project is under-spending to-date.

5. Discussion items

a. Bloor Beautification Project

Rita Bilerman gave the Board an overview of the Bloor Beautification project. The goal is to beautify the streetscape along Bloor bordering the Annex and Harbord Village by cleaning the sidewalks of garbage, pigeon poop and gum using various methods including power-washing. This would be very expensive so Rita is exploring possibilities for grants or other financial support for the project. Rita mentioned that ARA is fully supportive and she is seeking HVRA support. Members pointed out that BIA's and residents' cooperation is essential. It was suggested that BIA can apply for funding from the City.

Gus moved and Neil seconded that HVRA support the project and explore avenues to make it happen.

b. HVRA Dragon Boat

Christian reported that there are 5 people already practicing but 15 more are needed. The HVRA boat is called "Rusty Dragons". The race will take place on July 1st with proceeds donated to the Kensington Hospice.

c. Harbord Street Bike Lane meeting and off-Harbord Street parking

On June 27th a proposal for bi-directional bike lanes on the north side of Harbord will be unveiled including the locations for bike racks. Discussion by the board members included risks and benefits, concerns about parking and deliveries etc.

Gus and Christian volunteered to walk along Harbord Street with Tim in preparation for discussion at the June 27th meeting.

e. Proposal for free HVRA 1 yr membership for students

Tim suggested that cards be printed and dropped at student houses, encouraging them to sign up for a free one-year, non-voting status membership as a way to learn about upcoming events.
